() **VOLUNTEER JR. COUNSELOR** () 2nd year (tuition \$240.00) () 3rd year (tuition \$130.00)

() **ASSISTANT STAFF MEMBER** (must meet following requirements): Applicants should have at least 2 years experience as a Junior Counselor at Cali-Camp (it would be your 3rd year this year) and 16 years of age (as of 1st day of camp). Applicants assist counselors/specialists where needed (in Director's opinion) in the supervision of campers in recreational activities. There are 10 -15 available positions each year. This is a FULL TIME commitment for ALL of the 9 weeks of the summer. Acceptance as an Assistant Staff Member is highly predicated upon your previous summers evaluations and approval of the Director. The Camp Administrative Directors make all final decisions. Salary is **\$255.00** / week which includes bus supervision.

85% of counselor base (\$7.50) = \$6.38 per hour x 8 hours = **\$51.04/day x 44 = \$2,245.76 / summer**

Explanation: Assistant Staff members are assisting Sr. Staff in both the camp day and bus ride. Assistant Staff are paid for an 8 hour day - 5 days per week. If you are chosen to be a bus supervisor your pay will consist of 6.5 hours at 85% of counselor base plus 85% of bus supervisor salary (depending upon which route A,B,C or D:) (based on a 8 hour day = camp day plus bus ride)

Example: Assistant Staff is chosen to be a supervisor on a B Route. Salary would be:

Camp Portion of Day - 6.5 hrs x \$6.38 = \$41.47/day Bus Portion of Day - 2.5 hrs x 85% of 7.50 or \$6.38=\$15.95/ day
\$41.47 + \$15.95 = \$57.42 / day x 44 = \$2,526.48 / summer
